Submitted information in the official catalogue of the exhibition by the Exhibitor should contain followings:

- The name of director , postal address, Telephone, Fax, E-mail, Web-site;
- Brief information about the spheres of activity and product.

Information should be provided 25 days before the beginning of exhibition

### **Exhibitor:**

- send filled application for participation (attachment #1 to agreement) to organizer (application should be submitted 25 days before the organization of exhibitions begins);
- follow the work schedule of exhibition;
- follow technical safety rules, fire safety and sanitary, does not disturb the work of other exhibitors and organizers;
- release booths and exhibition stands and other equipments given for use by organizer .  
In the case of damage or loss of exhibition equipment due to the fault of exhibitor should pay its full cost within 5 days after exhibition closure.

### **Exhibitor is not entitled to:**

- allocate exhibits outside his booth;
- demonstrate goods and services not corresponding to exhibition subject.
- transfer his rights to participate in the exhibition to third persons.
